RELEASE AND RECORDING ASSIGNMENT

By registering and participating at the 2018 Gaylord Nelson Audubon Society's Chippewa Valley Nature Festival, I agree to the following:

Knowing these facts, and in consideration of acceptance to enter the Gaylord Nelson Audubon Society's Nature Festival, I hereby for myself, any child I may choose to bring, our heirs, assigns, personal representatives or anyone else who might claim on our behalf, hereby accept and assume all risk, covenant not to sue, and waive, release, discharge, and agree to indemnify the Gaylord Nelson Audubon Society, Inc. (the GNAS), other participants, sponsors, advertisers, organizations associated with the GNAS, volunteers, and their respective officers, agents, and employees, from any and every claim, damage, cost, or cause of action which may be sustained or incurred by a participant in connection with the Nature Festival, including death, permanent paralysis, other personal injury or property damage of known or unknown origin, even if caused by a releasee intentionally or through negligence.

The undersigned further grants full permission to the GNAS and those it authorizes to use any photographs, videos, audio recordings or any other record of participants for any purpose, including profit. The GNAS reserves the right to restrict or remove any participant which its official in his sole discretion deems inappropriate.
